World Racing Group, Inc., together with its subsidiaries, engages in the marketing and promotion of motor sports entertainment in the United States. It operates seven dirt motor sports tracks in New York, Pennsylvania, and Florida. The company also owns and operates four premier sanctioning bodies in dirt motor sports: the World of Outlaws; DIRT car Racing and United Midwestern Promoters; and the Mid America Racing Series. World Racing Group, through these sanctioning bodies, organizes and promotes national and regional racing series, including the World of Outlaw Sprint Series and the World of Outlaws Late Model Series. The company was formerly known as Boundless Motor Sports Racing, Inc. and changed its name to Dirt Motor Sports, Inc. in 2005. Further, it changed its name to World Racing Group, Inc. in January 2008. The company is based in Concord, North Carolina.

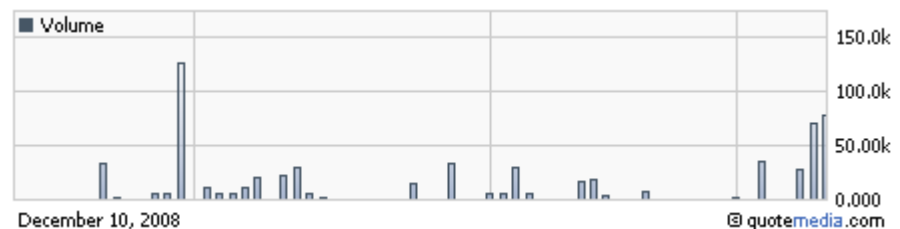
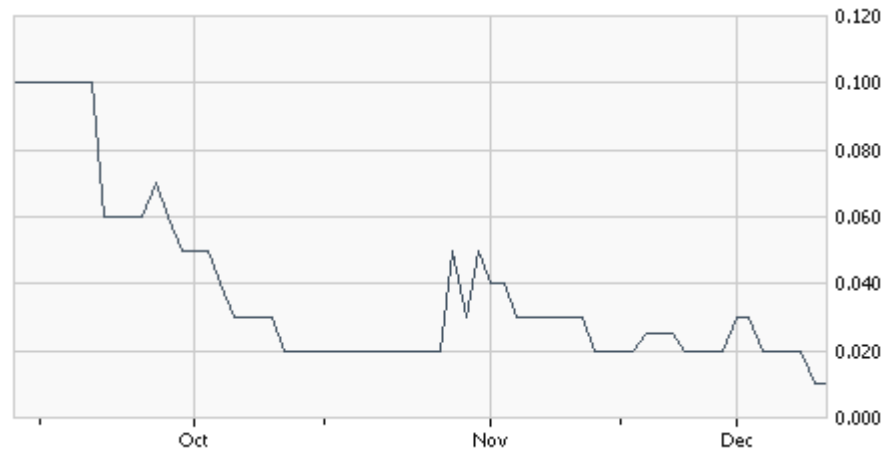
